Dear Mr. Loeffler:

This responds to Ms. Jennifer K. Harbury's request under the Freedom of Information Act dated 9 January 1995. Therein she requested records concerning Efrain Bamaca Velasquez and related matters from 1 January 1992 to the present. A search of DIA's systems of records located 284 documents. Of these, 244 have been referred to other government agencies for their review and direct response to you as they did not originate with DIA.

Only the relevant portions of these documents have been reviewed for a determination of their releasability. In addition, the unclassified data is also furnished. Should Ms. Harbury wish the non-responsive portions of these documents, please submit a request for this material. The new request will be placed in the same order for processing as the original request.

Upon review, it has been determined that some portions of 38 documents are not releasable. The information withheld is exempt from release pursuant to 5 U.S.C. 552 (b)(1), (b)(2), and (b)(6), Freedom of Information Act. Subsection (b)(1) applies to information properly classified under the criteria provided by Executive Order 12356. Subsection (b)(2) applies to information which pertains solely to the internal rules and practices of the Agency. Subsection (b)(6) applies to information which if released would constitute an unwarranted invasion of the personal privacy of other individuals. Portions of six of the documents contain information furnished by other government agencies and have been referred to those agencies for their review. Upon the return of the documents to DIA, any reasonably segregable information will be furnished to you. Except as noted above, all reasonably segregable portions of the documents are attached hereto.

All substantive portions of the remaining two documents are not releasable. The portions withheld are exempt from release pursuant to 5 U.S.C. 552 (b)(1), (b)(2), and (b)(6) Freedom of Information Act. Portions of one of the documents contain information furnished by another government agency and have been referred to that agency for their review. Upon the return of the document to DIA, any reasonably segregable information will be furnished to you. At this time, there are no reasonably segregable portions of this exempt material.

JENNIFER HARBURY CONTINUES TO PUSH THE CASE VERY EFFECTIVELY IN THE U.S., MOST RECENTLY WITH NATIONAL U.S. TELEVISION COVERAGE OF HER CASE ON CBS AND ABC TO INCLUDE A LIVE TELEVISION INTERVIEW ON CBS JUST YESTERDAY (941114). MG GONZALEZ WAS THEN GIVEN A TRANSCRIPT OF THE 941114 CBS INTERVIEW WITH JENNIFER HARBURY, THE 941109 NEW YORK TIMES EDITORIAL ON THE SUBJECT, A MIAMI HERALD EDITORIAL, AS WELL AS SEVERAL OTHER ARTICLES FROM U.S. PRESS SOURCES. MG GONZALEZ COMMENTED THAT ALL OF THESE ARTICLES WOULD BE EXAMINED WITH GREAT INTEREST.







OTHERWISE, THE BAMACA CASE WOULD BECOME AN UNRESOLVED FESTERING SORE IN THE USG RELATIONSHIP WITH THE GUATEMALAN ARMY, MUCH AS THE MICHAEL DEVINE CASE CONTINUES TO BE TO THIS DAY.

Recent allegations of ties to the CIA have made him even more controversial. Although no tangible evidence is available, many observers believe *Alpirez* was involved at least in the coverup in the first incident.

~~(S/NF)~~ The colonel is a probably a *kaibil*, a special forces officer. (Although no specific training for this elite group is listed for *Alpirez*, it nonetheless is likely because he served two tours at the Kaibil Training Center.) He has a reputation as an excellent intelligence officer. He has served in the D-2 office and as the head of the presidential security team for former President Cerezo. *Alpirez* is also known for having served successfully in difficult and remote areas of Guatemala.

The colonel was a target of criticism for the dissident group, "Officers of the Mountain," in 1988. In 1993, the Guatemalan National Revolutionary Union (UNRG) also demanded that *Alpirez* be investigated for human rights abuses.
