Dear Sergeant Gallagher:

This responds to your Freedom of Information Act (FOIA) request of December 28, 1992. Our interim response of January 29, 1993, refers.

Due to the size and complexity of the Department of Defense (DoD), there is no central repository for all DoD records. This Directorate is responsible for responding to requests for records of the components of the Office of the Secretary of Defense and Joint Staff (OSD/JS). The several Components of the DoD, including the military departments and separate defense agencies, operate their own Freedom of Information offices to respond to requests for records for which they are responsible. These procedures are provided in DoD Regulation 5400.7-R, as published at 32 CFR 286.

Accordingly, your request has been referred to the Department of the Air Force for documents responsive to item 1, with the request that they respond directly to you. For your information, their address is:

The Directorate for Defense Information (DDI), Office of the Assistant to the Secretary of Defense (Public Affairs), and the Organization of the Joint Staff (JS) have provided the enclosed documents as responsive to the remainder of your request.

Major General Charles T. Robertson, USAF, Vice Director, Joint Staff, an Initial Denial Authority, has denied a portion of one document pursuant to Section 1.3 (a) (1) of Executive Order 12356, and the provisions of 5 USC 552 (b)(1) which pertains to classified information concerning military plans, weapons, or operations.

You may appeal General Robertson's decision to deny the information by offering justification to support reversal of the initial denial. Any such appeal should be forwarded within 60 calendar days of the date above to the Office of the Assistant to the Secretary of Defense for Public Affairs, Directorate for Freedom of Information and Security Review, Room 2C757, 1400 Defense Pentagon, Washington, D.C. 20301-1400.

In further response to item 2 of your request, DDI stated there was no 27Dec92 press release on the US-Iraq aerial engagement in Southern Iraq "no fly zone."

Additionally, in response to item 7 of your request, the JS stated they have no records responsive to your request for DoD rebuttals for JUST CAUSE and DESERT STORM.

There are no assessable fees for this response in this instance.
