SUBJ: F-14 PROGRAM PERSONNEL REQUIREMENTS(U)

1. A MOU BETWEEN USG/GOI HAS BEEN SIGNED SPECIFYING 60 IN-COUNTRY CONTRACTOR SUPPORT PERSONNEL FOR THE F-14 PROGRAM.
2. DUE TO CONDITIONS IN IRAN THERE HAS BEEN PRESSURE ON THE PART OF CONTRACTORS TO REMOVE ALL PERSONNEL FROM THE PROGRAM, IT IS THE CARMISH MAAG POSITION THAT IN ORDER TO PROVIDE ADDITIONAL PROTECTION AND SURVEILLANCE OF SENSITIVE EQUIPMENT AND PUBLICATIONS AND TO SUPPORT CONTINUED IIAF FLIGHT OPERATIONS IT IS ESSENTIAL TO THE F-14 PROGRAM TO MAINTAIN A CADRE OF APPROXIMATELY 60 CONTRACTOR WITH SELECTED SKILLS ON THE PROGRAM. IT IS RECOGNIZED THAT THE MAJORITY OF THE CONTRACTOR PERSONNEL ARE TEMPORARILY OUT OF COUNTRY, HOWEVER THE TEAM SHOULD BE MAINTAINED AND RETURN TO IRAN WHEN CONDITIONS PERMIT.
3. REQUEST YOUR ASSISTANCE AND SUPPORT IN RETAINING THE ABOVE MENTIONED CONTRACTOR SUPPORT OF THE F-14 PROGRAM.
