
Dear Mr. Campbell:


Dear Congressman Wolf:

Thank you for the letter you signed with Representative Bishop requesting the release of fiscal year 2007 funds to Morehouse College for the John H. Hopps Defense Research Scholars Program. This response is on the behalf of the Under Secretary of Defense (Acquisition, Technology, and Logistics).

The \$1 million in funding for the program was appropriated to the Defense Advanced Research Projects Agency (DARPA). We recently executed a reprogramming action to transfer the funding to the Historically Black Colleges and Universities and Minority Institutions program under the Director, Defense Research and Engineering (DDR&E) to ensure technical oversight and proper execution of these funds. This realignment is consistent with previously appropriated funding for the program.

These funds, now properly aligned, should be committed early in August and obligated so there are no delays with the contract award process for the John H. Hopps Defense Research Scholars Program.

The Assistant Secretary of Defense for Legislative Affairs requested that I respond to your letter regarding rules of engagement (ROE) and your concern about the safety and welfare of our men and women serving in Iraq.

I can assure you that the scenarios and conclusions regarding ROE that are described in the newsletter you received are not consistent with the policies and regulations provided to US military personnel in Iraq. Commanders and individuals have the inherent right and obligation to take appropriate action in self-defense, to include responding to acts of violence and the imminent use of force against US forces. The ROE are continually reviewed and refined to ensure they stay applicable and relevant.

In preparation for deployment and prior to entering the US Central Command area of operations, all units, to include combat, combat support, and combat service support, receive formal ROE training. Commanders also conduct scenario-based training for all personnel to ensure their troops understand the ROE and can apply them in realistic scenarios.

I am confident that our forces are provided the ROE authority they need to act decisively in the challenging counterinsurgency environment of Iraq. Your continued support of our Service members is appreciated.

(b)(6) received information that our web site listed facts, figures, and stories, clearly illustrating that progress is being made, in Iraq, through the efforts of the United States and Iraqi governments. She apparently verified that this information was posted and was bothered by the lack of media reporting on these indicators of success.

I can confirm for you that our web site does carry information about progress in Iraq. The information is updated regularly and is posted for the public as part of our public affairs mission to inform and educate the American people about the Department's operations and activities. I cannot explain, nor can I comment on, the commercial media's seemingly limited use of this information. I can only say that it is posted to the web for any citizen or member of the media to access.

I trust this information will help you in responding to (b)(6) query. There she will find the latest news and information on the department with numerous links to our global operations, including those in Iraq.



Thank you for your letter of July 6 on behalf of your constituent, (b)(6) regarding his proposal to use the Food and Drug Administration (FDA) drug approved drug for obesity, sibutramine, to cure posttraumatic stress disorder (PTSD) in Service members and to diagnose PTSD using brain functional neuroimaging.

Sibutramine affects several neurocircuits in the brain, some of which may be impaired by traumatic brain injury (TBI), and in some cases, PTSD. Not all cases of PTSD are caused by trauma nor require functional neuroimaging to diagnose. Also, many cases of PTSD do not respond to well-studied and established medications approved by the FDA for PTSD.

Congressional funds were recently appropriated for research in TBI and PTSD. (b)(6) and his colleagues may wish to consider submitting proposals to further study effective treatments for PTSD. The Congressionally directed medical research program recently placed 16 requests for such proposals on their Web site: (<http://cdmrp.army.mil/funding/default.htm>).

Like Dr. (b)(6) we look forward to expanding the evidence base for treating TBI and PTSD. We appreciate his commitment to doing so and look forward to establishing the evidence base necessary to include new treatment approaches in our armamentarium.

I hope you will find this information useful. Thank you for your interest in the Military Health System.
