Micaela, on the issue of adult children of married Members of Congress traveling on CODELs on the existing authority for CODEL travel (31 USC 1108g), our position remains as stated in Mr. Wilkie's March 29th letter to the Speaker (attached). This is consistent with our existing DoD Directive, 4515.12, DOD Support for Travel of Members and Employees of the Congress.

As I mentioned in our conversation, we will continue to honor the long-standing practice of adult children of unmarried Members traveling for protocol purposes when authorized by the Speaker or a Full Standing Committee Chairman.

Janice, our DoD Directive for Congressional travel (DoD Directive 4515.12) prohibits travel of dependents of members and employees of Congress on military air. Exceptions may be made by the Secretary of Defense to permit dependents -- with or without reimbursement -- when:

- 1) Essential to the proper accomplishment of the mission;
- 2) Desirable because of diplomatic or public relations; or
- 3) Necessary for the health of the principal (e.g., Member of Congress).

The directive grants OSD the discretion to determine when reimbursement is appropriate. Exception #2 is the basis upon which we authorize travel of spouses to accompany Members for protocol purposes.

There is no authority in our Directive to fly Members' spouses without the Member.

Dear Madam Speaker:

As you know, my office is responsible for management of the Congressional travel program and has been working closely with your staff on a number of matters over the past several months. We have sought to develop a regular order in our collective administration of the CODEL program and to ensure your staff has our best advice. John Lawrence, Mike Sheehy, and Bernie Raimo, in particular, have familiarized themselves with this important program and have worked cooperatively with my staff. I'm pleased that the transition to the 110<sup>th</sup> Congress has been constructive and collegial, and I thank you for your courtesy in this matter.

I am writing to address two concerns we have with the guidelines you issued to your Committee Chairs. In your January 23, 2007 letter, two of your guidelines contain provisions that either are only partially being followed or impose on the Department of Defense obligations that are contrary to our regulations.

The first issue concerns travel of adult children of Members for protocol purposes. Your letter states: "*If a member of the committee does not have a spouse, an adult child of the member may be authorized to travel for protocol purposes only.*" Currently, this rule is being partially observed insofar as adult children of married Members of Congress have been authorized to travel. To clarify our position, in the future if authorized by the Speaker or a Committee Chair to travel on CODELs for protocol purposes, it will be DoD policy to require that adult children of married Members of Congress reimburse the Treasury of the United States at the unrestricted coach air fare and that all other costs are at no expense to the government (e.g., hotels, meals, tips, ground transportation, etc.).

Second, we are concerned that private citizens are now authorized to travel on CODELs on your approval. Your letter states, "*Authorization for an adult who is not the spouse or adult child of a member of the committee to travel with a member for protocol purposes may be provided by the Speaker.*" In practice, this will allow private citizens to travel on an appropriation that specifically was intended for Members and employees of the Congress. Private citizens may travel on CODELs only when such transportation is determined to be in the overall official interest of the Department of Defense and the Secretary of Defense issues an invitation.

We have supported the Congress with Secretary of Defense invitations under this rule on a number of occasions in the past, to include Presidentially-directed missions, mission-essential delegates to national security conferences, NATO Parliamentary Assembly visits, and Military Service Academy Board of Visitor meetings, among others. We will continue to operate under these guidelines. If we determine that it is appropriate to issue a Secretary of Defense invitation, upon your request, we will then determine whether it will be on a reimbursable basis to the Treasury of the United States at the unrestricted coach fare or on a nonreimbursable basis.

We look forward to continuing to build on our positive relationship in managing the CODEL travel program and hope that your staff will feel free to contact us if you have any questions on these matters.

Janice, DoD Directives for Congressional travel and even DoD "official travel" prohibit dependents from traveling unless specifically authorized and carefully controlled.

For Congress, DoD Directive 4515.12 prohibits travel of dependents of members and employees of Congress on military carriers. Exceptions may be made by the Secretary of Defense to permit dependents -- with or without reimbursement -- when essential to the proper accomplishment of the mission, desirable because of diplomatic or public relations, or necessary for the health of the principal. The directive grants OSD the discretion to determine when reimbursement is appropriate. We have accepted the long-standing practice of adult children of unmarried Members accompanying for official protocol purposes, and will continue to do so. For travel of adult children of married members, the Department will ask that they reimburse at the unrestricted coach fare.

For DoD required travelers, the controls for dependent travel is similar:

E2.2.3. Unofficial Travel. Such travel is by a family member, non-DoD civilian, or non-Federal traveler only when accompanying a senior DoD or other Federal official who is traveling on a military aircraft on official business. This category of travel differs from the space available privilege in DoD 4515.13-R, Chapter 6 (reference (g)) since it is limited to travel in the company of a senior DoD official and is reimbursable by the traveler at the full coach fare, as required by OMB Circular A-126 (reference (b)). Such unofficial travel is not authorized on MilAir unless the aircraft is already scheduled for an official purpose; this noninterference use does not require a larger aircraft than needed for the official purpose; official travelers are not displaced; it results in negligible additional cost to the Government; and the Government is reimbursed at the full-coach fare (the senior DoD official shall attach to his or her travel voucher a personal check made payable to the Treasurer of the United States and shall include a travel office printout that reflects the full-coach fare). Unofficial travel shall be carefully controlled by requiring approval in advance and in writing by the approval officials in section E2.4., below. "Required use" travelers shall approve all unofficial travelers who accompany them, provided that the travel is in compliance with this paragraph.

I hope this helps. John states it well below: the permission to travel -- extended by the Speaker or a Committee Chair -- does not waive an obligation to repay. Please let me know if you have any questions.
